

## Castle Shannon Vol. Fire Department (CSVFD) 2018 Annual Carnival Car Raffle Rules

- Cost of tickets \$1.00 each
- Tickets will be sold up to 30 minutes prior to drawing.
- Drawing will be held on Saturday, August 4, 2018 once the carnival is closed.
- Raffle is based on a drawing, NOT PA LOTTERY NUMBERS. Numbers displayed on tickets are for internal accounting purposes only. Name, Address and/or phone number on winning ticket will be used to verify winner.
- Each winning ticket will be drawn by a carnival patron and witnessed by a separate carnival patron 18 years of age or older.

- A list of raffle witnesses can be obtained via the CSVFD Business Office during business hours.
- Vehicles used during raffle sales are for display purposes only. CSVFD or its dealership partner does not guarantee vehicles used in advertising will be available as a prize vehicle. Prize vehicle is limited to dealer inventory.
- Winner of the 1<sup>st</sup> prize has the ability to choose any vehicle from the official dealership partner, up to the listed prize value below. Prize value includes the cost of the vehicle, any sales tax owed, registration fees, additional options added to vehicle, and any other fees related to the purchase of the vehicle. **FEDERAL INCOME TAX OWED IS NOT INCLUDED IN THE PRIZE VALUE AND IS THE SOLE RESPONSIBILITY OF THE WINNER.** If the total purchase price of the vehicle is over the listed prize value, CSVFD will only supply funding for the prize value and any money owed will be the responsibility of the winner. No money will be awarded if the winner chooses a vehicle that costs below the prize value. Credit approval/proof of funding must be provided before CSVFD releases money to dealership. Once a prize vehicle has been chosen, CSVFD will work directly with dealership to exchange funds. No funds will be turned over to winner to purchase prize vehicle. Winning prize values are listed below.
- Vehicle selection must be performed at the official CSVFD dealership partner listed below.
- Winner of the 1<sup>st</sup> prize (Vehicle/Cash) has 30 days to notify the CSVFD Carnival Committee of prize chosen. Credit approval or additional funding (if necessary) for vehicle must be obtained within this 30 day period. If no prize is chosen or winner is unable to obtain any additional funding required, winner will forfeit his/her right to the vehicle and will be given the cash option.
- Any prize not collected within 90 days of drawing will become property of CSVFD.
- Time restrictions listed above are from the time of prize drawing, not winner notification.
- Winners of the 1<sup>st</sup> prize (Vehicle/Cash), 2<sup>nd</sup> prize (\$7,000.00) and Special Resident Raffle (\$1,000.00) will be issued the necessary forms for Federal Income Tax purposes. Tax forms will reflect the actual prize value awarded. Winners' information will be forwarded to the IRS for processing. Due to federal laws, CSVFD may be required to collect the value of Income Taxes owed prior to a prize being released to the winner.
